

# KIMBER® DEALER REWARDS

## THE PROGRAM

KIMBER established this program to reward dealer sales associates for supporting our brand. Qualifying sales will result in rewards\*.

## SUMMARY

The Kimber Rewards Program is provided by Kimber Mfg., Inc. and is available to any eligible salesperson employed by a federally licensed firearms retailer that sells new Kimber brand firearms.

By selling eligible Kimber firearms between the period of July 1, 2019 and September 30, 2019, subject to all local, state, and federal laws and regulations, eligible dealer salespeople will be eligible to submit them to Kimber as qualifying sales. Only new Kimber brand firearms in the **1911**, **Micro 380**, **Micro 9**, and **EVO SP** product families sold between July 1, 2019 and September 30, 2019 qualify for the Kimber Dealer Rewards Program. Subject to Terms and Conditions on page 2.

In order to result in rewards\*, all qualifying sales must be properly submitted to the following URL: <https://rapid-rebates.com/KimberDealerRewards>, and all terms and conditions of this program must be strictly adhered to.

## HOW TO PARTICIPATE

Eligible dealer salespersons must visit <https://rapid-rebates.com/KimberDealerRewards> any time beginning July 1, 2019 through October 31, 2019, strictly follow the redemption instructions and all other terms and conditions, and provide all required documentation.

## QUESTIONS & ANSWERS

### Q. HOW LONG DOES THE PROCESS TAKE?

A. Once you have submitted everything to redeem your reward, please allow 4-6 weeks for delivery of the reward\*.

### Q. IT IS EASIER FOR ME TO SUBMIT THE SALES LOGS FROM WORK, CAN I USE THAT INSTEAD OF THE 4473?

A. No, only page 3 of Form 4473 will be accepted and approved.

### Q. CAN THE EMPLOYEES IN MY STORE SHARE SALES?

A. No, this is an individual sales program. Please do not submit sales that you did not make yourself. Duplicate sales will be deleted.

### Q. WHY DO YOU NEED MY SOCIAL SECURITY NUMBER?

A. Prizes awarded over a certain amount are subject to be taxed. If you are over that amount by the end of the year, you will receive a 1099 form from Kimber.

## TERMS AND CONDITIONS

The following terms and conditions apply to the 2019 Kimber Dealer Rewards Program:

**Eligible Salespersons.** To be eligible for the Kimber Dealer Rewards Program, you must be at least 21 years of age and a salesperson legally employed by a retail firearms dealer (your "Employer") that has a valid, active, and current federal firearms license. Your Employer must (1) have a regular place of business, (2) maintain regular business hours, and (3) offer for sale Kimber brand firearms to the shooting public. Where applicable, your Employer must also have a state resale tax number.

**Qualifying Firearms.** Only new Kimber brand firearms in the 1911, Micro 380, Micro 9, and EVO SP product families sold between July 1, 2019 and September 30, 2019 qualify for the Kimber Dealer Rewards Program. Kimber Rifles, Revolvers, Special Edition and Commemorative firearms to not qualify. Pre-owned, used, and law enforcement tax exempt sales do not qualify for this program. (see Kimber Dealer Rewards Program website for the list of qualifying firearms and rewards revenue\* needed for redemption, <https://rapid-rebates.com/KimberDealerRewards>).

A qualifying firearm is sold when the consumer's ATF Form 4473 is submitted and approved, and the consumer takes possession of the firearm. Once this process is completed, you may access the Kimber Dealer Rewards webpage and submit the sale for consideration as a qualifying sale. Only one eligible salesperson may submit a claim for each eligible firearm sold. The webpage: <https://rapid-rebates.com/KimberDealerRewards>.

**Qualifying Sales.** Sales of eligible firearms must occur between July 1, 2019 and September 30, 2019 in order to be considered as qualifying sales. The sales must be submitted through the Kimber Dealer Rewards webpage no later than 11:59 PM EST on October 31<sup>st</sup>. Any submission that is late, incomplete, or otherwise deficient will not be counted, is void, and is ineligible; failures to timely submit also are void and ineligible. Participants may not trade, sell, combine, or exchange qualifying sales with each other or with anyone else.

Lost, stolen, misdirected, missing, damaged, or destroyed submissions. Kimber is not responsible for any lost, stolen, misdirected, missing, damaged, or destroyed submissions.

**Receiving Your Rewards.** Kimber Dealer Rewards Program rewards will be shipped at Kimber's expense to the address you provide in the submission process.

**Verification.** Kimber must verify each of your submitted qualifying sales before you can redeem a reward. Any submitted sale(s) or that cannot be properly verified are void and ineligible.

**Local, State, and Federal Laws.** The Kimber Dealer Rewards Program is subject to all local, state, and federal laws and regulations. Prior to participating in this program, ensure that you may lawfully redeem therewards.

**IRS Form 1099.** Any participant who redeems qualifying sales with an individual or combined value of \$600 or more must complete an IRS Form W-4 so that Kimber may issue you an IRS Form 1099 in accordance with federal law. The value of any firearm or accessory will be determined based on Kimber's distributor pricing in effect at the time the reward is released for shipment. The IRS Form 1099 will be issued for the combined value of all rewards shipped by Kimber to you in a given calendar year.

**KIMBER's Right to Amend or Cancel.** Kimber reserves the right to amend or cancel the Kimber Dealer Rewards Program at any time. Kimber also reserves the right to suspend or revoke any individual's participation in the Dealer Rewards Program at any time if Kimber determines, in its sole discretion, that the individual has failed to abide by or follow the terms and conditions set forth herein.

This program is void where prohibited by law and is only valid within the United States. Forfeiture of rewards: Any qualifying sales not submitted by 11:59 PM on October 31, 2019 or otherwise in accordance with the terms and conditions set forth herein will be forfeited.

### Other Term and Conditions
